

In the event of failure of such dialogue /discussions/negotiations, the matter shall be referred to a binding arbitration under the rules of arbitration and Conciliation Act 1996. The arbitration shall be in English language and the venue of arbitration shall be at Chennai, India. The costs of such arbitration shall be borne on the basis of the award passed by the arbitrators.

#### **IX .Publicity:**

- All publications whether through print or any other media connected with the activities pertaining to this MOU will be done after review and express approval of the College and ACS.
- Any release and use of the publications referred to above shall be done only upon express written approval of the College and ACS.
- The College shall execute necessary confidentiality agreements or non- disclosure agreements as stipulated by ACS in this connection.
