**7. Eligibility Clause**

- a) Any student who is pursuing or completed class 12<sup>th</sup> or Pre-degree or any other course acceptable to ACCA with minimum of 65% marks in English and Maths or Accounts and a minimum of 55% in all other subjects and otherwise meets the general conditions of Anna Adarsh College for Women can be admitted.

8. 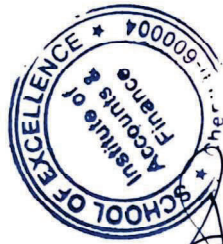



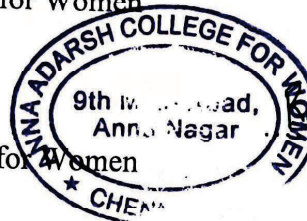

### Objectives




## **VII. Confidentiality**





#### Article I: Financial Obligations, Amendments and Termination




1. The protection of intellectual property rights shall be enforced in conformity with the respective national laws, rules and regulations of the organizations and with other international agreements signed by both organizations.




